

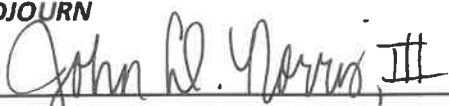

The Council reserves the right to retire into executive session concerning any of the items listed on this Agenda, whenever it is considered necessary and legally justified under the Open Meetings Act.

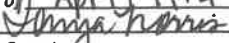

Attorney Sarah Ross discussed the Sub-Division Ordinance draft. Brief discussion on the standards that the City would like implemented in the ordinance. Sarah suggested the North Texas Council of Government (NTCOG) standards for streets, curbs, sidewalks, etc. NTCOG standards are pretty strict. This would allow for all of our bases to be covered. Variances and waivers can be issued on a case by case situation. These adjustments will be made in the ordinance and a new draft presented next month. No action taken.
